WEIGH-IN: Weigh-In is Required for all Sparring Athletes.

<sup>\*</sup>Competitors may change weight on-site but must do so before stepping on the official weigh-in scale and must pay the \$100.00 administrative fee before weight category is changed.



AWARDS: Medals will be awarded to 1st, 2nd, and two 3rd places.

**BOARD BREAKING:** Flying Side Kick Only - Athletes who jump longest at their belt level height and break a board shall be the winner.

One DEMO Board will be provided at ringside with breaking event registration.

**EQUIPMENT:** There is no requirement for athletes to use only USA Taekwondo brand gear and uniforms at State Championships. USA Taekwondo strongly encourages our athletes to use USA Taekwondo brand uniforms and gear so that our brand becomes more visible, but once again, there is no requirement to do so at State Championships, or at local USAT-sanctioned events. V-neck uniform only (no color trim except on black belt v-neck) All White, Yellow, Green and Blue Belt Kyorugi competitors must wear: white, red or blue head gear (red & blue headgear must be matched with chest protector color) and, red and blue reversible chest protector, forearm guard, shin and instep guard, groin cup (males only, worn inside) and CLEAR mouthpiece. Each competitor must provide his or her own equipment. **All Kyorugi competitors Red Belt & Above MUST HAVE DAEDO BODY PROTECTORS & DAEDO SOCKS. DAEDO Protectors must be rented for \$20.00 at the tournament site. Competitor must provide own DAEDO Socks.** 

**RULES:** Current USAT Competition rules will govern this championships.

#### IMPORTANT NOTICE

All participants must be current USA Taekwondo members. All coaches, referees, club owner/instructors 18 and older are required to complete and pass the USAT background check prior to being a member of USAT and registered for USAT state sanctioned event (background checks must be completed every two years).

- Athletes must hold the appropriate U.S. citizenship or residency depending on the division in which he/she participates.
- All coaches must be, at minimum, AC certified within the USAT CIDP program.
- An athlete MAY qualify in the same WORLD CLASS weight Sparring & Poomsae category in MULTIPLE STATE CHAMPION-SHIPS.

12 YEARS AND OLDER BLACK BELTS - Those who are competing in Sparring or Poomsae MUST be a U.S. Citizen. Proof of Citizenship is fulfilled only by showing a U.S. Birth Certificate or U.S. Passport. Social Security Cards ARE NOT A VALID PROVE OF CITIZENSHIP. Athlete MAY qualify in the same WORLD CLASS weight (sparring) and/or age category (Poomsae) in MULTIPLE STATE CHAMPIONSHIPS.

**FOR ALL OTHER DIVISIONS** - Proof of Residency is fulfilled only by showing ONE of the following documents: Social Security Card, Green Card, School Report Card/Official U.S. College Transcript, and in some circumstances a valid U.S. driver's license.

If an individual is not a valid resident or U.S. citizen, he/she will not be allowed to compete at the State Championships period.

- 1. Picture Identification Card To pick up your credentials.
- 2. Proof of current year's USA Taekwondo Membership.

- 4. Proof of Athletes appropriate U.S. Citizenship or Residency depending on the division he/she participates in.
- 5. Signed Athletes / Coaches registration documents from Hangastar.
- 6. Black Belt Athletes Copy of Black Belt Certificate or ID Card
- 7. If Minor, guardian must be present with an athlete to sign a waiver and release of liability form.
